## Solulene® Thinners for solvent based sealers

### Product

Bescon Solulene® is a clear liquid hydrocarbons for use as a dilutant or extender in acrylic and lacquer coatings.

### Usage

- ▶ Dilution of solvent based sealers
- ▶ Cleaning of application equipment
- ▶ Treatment of previously sealed concrete surfaces
- ▶ Treatment of sealer blistering

### Dilution rate

Approximately between 10-50% dilution, depending on application. Refer to Sealer Technical data sheet or label for appropriate dilution rate.

### Package

5 lt, 10 lt, 20 lt pails

### Tips

#### Sealer blistering

This is due to moisture trapped under the surface of recently applied sealer. To assist apply liberal amounts of Solulene® to the affected areas, and allow the Solulene® to react with the sealer for approximately 30 seconds and then work it into the surface using a light rubbing motion with a broom.

Allow the coating to dry and assess if the problem has been rectified. If the problem has not been rectified, then the sealer should be removed with Bescon Sealer stripper, removing all traces of the sealer prior to resealing.

#### Sealer compatibility

Prior to sealing it's advisable that a small area be tested for compatibility. Apply Solulene® liberally and broom in vigorously, then leave to weather for a minimum 24 hours. If the test area fails, (delamination, flaking, cracking) then the old sealer should be stripped with Sealer Strippa. If the test area remains soft and tacky, then it is compatible. Apply Solulene® liberally with a broom and work into the surface,

Once concrete is completely dry, apply StaSeal® Premium concrete sealer as per application guidelines to enhance the colour and protect the surface.

### Shelf life

Approximately 18 months, providing stored correctly and unopened

### Storage

Store in a well protected dry area, well ventilated and away from excessive heat. Keep away from all ignition sources.

### Handling

Avoid contact with skin and eyes, wear gloves and eye protection. Avoid breathing vapours, wear respiratory mask.
